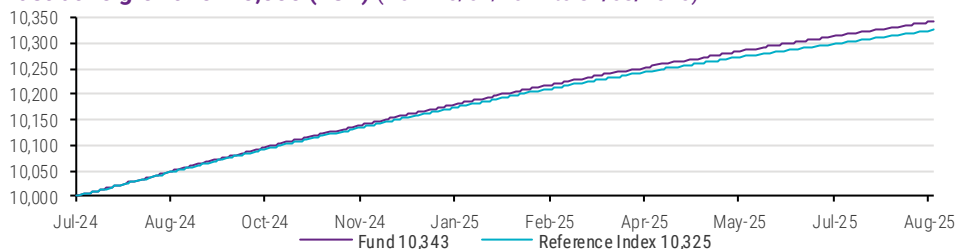

Fund highlights

- Standard variable net asset value money market fund seeking to investing cash over a 3-month horizon, implementing a socially responsible investment (SRI) investment process benefiting from the French government's SRI label.
- Money market instruments issued by corporate issuers and public or agency issuers, denominated in euros or other currencies (currency risk is systematically hedged).
- By way of derogation, the Fund can invest beyond 5% and until 100% of its NAV in any money market instrument individually or jointly issued or guaranteed by some sovereign, quasi sovereign or supranational issuers.
- Max. WAM (weighted average maturity) of 6 months and max. WAL (weighted average life) of 12 months.
- Securities are eligible for the fund based on Ostrum AM's "high credit quality" methodology based on independent proprietary credit research and extra-financial ratings.
- The fund presents a risk of capital loss borne by the investor. The net asset value may fluctuate and capital invested is not guaranteed. The Fund may not under any circumstance, rely on external support to guarantee or stabilize its net asset value. Investment objective

Internal rating

The only securities allowed into the Monetary Funds' portfolios are the one benefitting from the highest in-house notations (ST1 to ST4) and from a long term note corresponding to the highest credit qualities.

¹ In the absence of proprietary scores - defined by Ostrum AM credit research based on an internal rating methodology - external ratings will apply. The Ostrum AM scores are forward-looking to 3 years and provide an indication of the company's level of credit risk and its volatility over time. To facilitate comparisons and enable average portfolio ratings to be determined, these scores are translated into S&P equivalents. As a reminder, in accordance with the regulations, all investments in money market funds have been issued by issuers whose High Credit Quality has been validated by Ostrum AM, in accordance with its internal procedure.

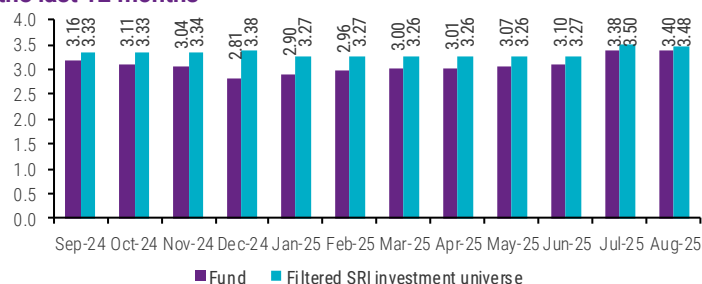

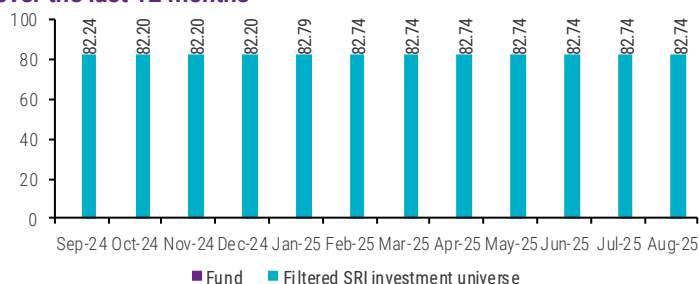

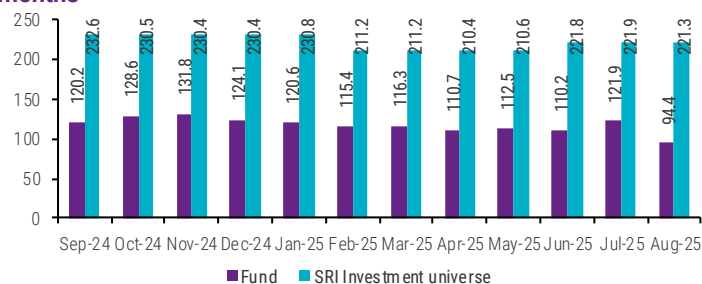

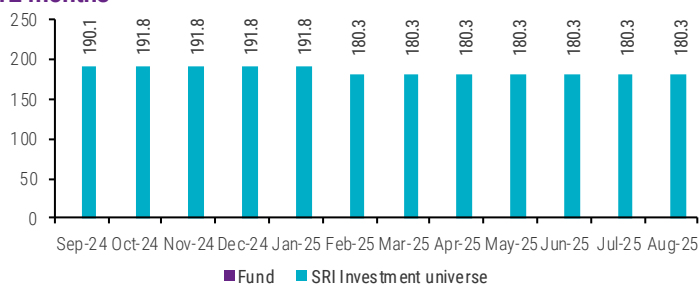

FUND MANAGER'S COMMENT

At its meeting of 24 July, the ECB left its key interest rates unchanged: the deposit facility rate at 2%, the "refi" rate at 2.15%, and the marginal lending rate at 2.40%. Thus, after ten consecutive hikes in its key rates since July 2022 and October 2023, for a cumulative total of 450bp, i.e. the sharpest rise in key rates since the creation of the euro in 1999 over such a short period of time, and after five consecutive status quo decisions and eight cuts in one year for a total of 200bp, the ECB opted for keeping them unchanged this time. As a reminder, the September cut was accompanied by a "restructuring" of the key rates by narrowing the spread between them. Therefore, while the deposit facility rate had been reduced by 25bp, the refinancing rate ("refi rate") and the marginal lending facility rate had been lowered by 60bp. By narrowing the spread between its key rates, the aim of the ECB was to reduce volatility on the interbank markets. As a result, the spread between the lowest and highest of these three rates is now only 40bp.

With regard to the various asset purchase programmes, the situation has not changed, with the ECB continuing to reduce the size of its balance sheet. For the Pandemic Emergency Purchase Programme (PEPP) portfolio, although the full reinvestment of the principal repayments of maturing securities was still in force throughout the first half of 2024, this portfolio was reduced by €7.5bn per month on average in the second half of 2024, and since the start of this year these reinvestments have stopped. Moreover, it should be noted that the last outstanding amounts of the TLTRO III (Targeted Long Term Refinancing Operation) matured last December.

Given the recent change in inflation, the pause decided by the ECB appears coherent: annual inflation rates in the eurozone were estimated at 2% in June and 1.9% in May, which is perfectly in line with the ECB's medium-term target of 2%. However, these estimates are only averages, and the various components recorded divergent trends. Thus, while food, alcohol and tobacco prices, as well as wages and industrial goods prices excluding energy slowed and energy prices continued to fall, services prices saw their highest annual increase in June at +3.3% compared with +3.2% in May. Moreover, at the national level, situations are very diverse within the eurozone: while France recorded inflation of just +0.8% in June, inflation remains high in other countries at more than 4%, or even higher than 5%, such as in Slovakia, Croatia and Estonia. These disparities clearly oblige the ECB to remain vigilant in this respect. In light of this mix of situations, the expectation of lower more uniform national inflation rates may also explain the pause in July.

However, it is equally clear that the current environment is very volatile in many aspects and is causing uncertainties, resulting in a global economic slowdown that could further affect a struggling European economy. Firstly, geopolitical risks are unfortunately still present: the war in Ukraine and the Israeli-Palestinian conflict and their possible extensions continue to weigh on consumer sentiment and make the equation more complicated for companies. Furthermore, on the currency market, the sharp appreciation of the euro against the dollar since the beginning of the year (around +15%), while it reduces the price of imports and contributes to lower inflation, is, however, severely penalising exporting companies. Lastly, the trade war declared by the US on the rest of the world via an unprecedented increase in trade tariffs, particularly vis-à-vis the EU, has generated a wait-and-see attitude among companies: the agreement reached at the end of July reduces this uncertainty, although not everything is fully set yet. Moreover, the ambiguous US attitude towards Ukraine forcing Europeans to borrow massively to finance the war effort necessary to ensure their own defence has resulted in a significant rise in long-term rates and budgetary resources that cannot be used to finance any stimulus plans. Thus, between the geo-political situation, the appreciation of the euro, the trade war and increased financing of military spending, the ECB's management of inflation is complex due to a deteriorating economic situation. However, the agreement reached at the end of July between the EU and the US on "general" tariffs of 15% applicable to European exports, although much remains to be negotiated, at least removes some uncertainty.

Concerning economic growth in the eurozone, we recall that, while in 2020 GDP had declined by -6.4% due to "Covid", it had rebounded by +5.2% in 2021 after the lockdowns ended. Then in 2022, growth in the eurozone came in at +1.8% despite the recessionary effects of the Russia-Ukraine conflict. However, growth slowed sharply in 2023 to +0.5%. And in 2024, eurozone GDP grew by +0.9%. Unexpectedly, Q1 2025 GDP was revised up to +0.6% quarter-on-quarter and +1.5% year-on-year. However, in Q2 2025, the situation normalised, with GDP falling back to +0.1% quarter-on-quarter and +1.4% year-on-year. These latest Q2 figures reveal sluggish economic activity despite the Q1 figures suggesting the start of an improvement: this could be a resurgence of a wait-and-see attitude due to the trade war initiated by the US administration in early April. However, the HCOB (formerly Markit) Eurozone Composite PMI, combining services and manufacturing activity, came in at 51.1 for August vs. 50.9 revised in July (initially estimated at 51), therefore moving further up from the 50-point threshold separating growth and recession. While the services PMI decreased to 50.7 in August vs. 51 in July (initially estimated at 51.2), the manufacturing PMI rose to 50.5 in August vs. 49.8 in July. This is excellent news because it had been below 50 for 37 consecutive months with a low of 42.7 in July 2023! Eurozone growth could therefore be slightly stronger than previously expected. However, the future of growth in the eurozone is difficult to anticipate between remilitarisation efforts, the US-EU trade agreement, the ongoing tense geopolitical situation and the unstable political situation in some countries in the zone. Regarding headline inflation in the eurozone, we recall that it had peaked in October 2022 at an annual rate of +10.6% (the highest level recorded by the European Statistics Office since the indicator was first published in January 1997) before dropping steadily since. After hitting its lowest level in three and a half years at +1.7% in September, thanks to the drop in energy prices, eurozone headline inflation has bounced back month after month and reached +2.5% in January. However, it has since stabilised at around 2%. Growth in August thus came in at +2.1% vs. +2% in July and June and +1.9% in May. Likewise for core inflation (excluding energy, food products, alcoholic beverages and tobacco), the central bankers' benchmark indicator, which was unchanged in August at +2.3% like in July, June and May, thus remaining at its lowest level in 42 months. In both cases, the 2% seems to be a floor that is difficult to cross. Regarding the unemployment rate in the eurozone, it rose slightly in May to 6.3% vs. 6.2% revised in April, and is thus very close to its all-time low of 6.2% since the European Statistics Office began compiling this series in April 1998 for countries that adopted the single currency, and still remains far below its pre-pandemic level of 7.4% in February 2020. We therefore observe that the extremely low level of growth in the eurozone has still not really passed through to unemployment figures. However, the many production site closures recently announced in both France and Germany, the rise in business failures and the slowdown in investment due to commercial, political and geo-political uncertainties could start to weigh on employment trends in the coming months.

Against this backdrop, in August, the average monthly Ester rate stood at +1.924% (+1.923% in July), the monthly average 1-year OIS swap rate at +1.824% (+1.769% in July) and that of the 3-month Euribor at +2.021% (+1.986% in July).

Regarding eurozone bond yields, they increased almost continuously from early 2021 until early October 2023, when they reached their highest level in response to the sharp rise in inflation and monetary tightening by the main central banks. But at end-2023, they fell dramatically in the wake of excessive expectations of key rate cuts in both the US and the Eurozone. At the start of 2024, these excessive rate cut expectations led bond yields to rise over the first half of the year. The second half of 2024 was characterised by an equal downturn but very erratic trends. After a continuous easing from July to September thanks to the concomitant fall in inflation on both sides of the Atlantic, eurozone bond yields fluctuated between October and February. These erratic movements were mainly the result of changes in expectations regarding growth and inflation levels in the United States. But in March, the rise in US bond yields following Donald Trump's announcement of unprecedented tariff hikes (Liberation Day) and the colossal financing needs for the European rearmament effort led to a sharp rise in eurozone yields. In April, these rates fell broadly in the wake of expectations of a global economic slowdown, and there was no clear trend in May. In contrast, the yield on the 10-year Bund rose significantly in June, July and August reaching +2.72% at the end of August vs. +2.69% at the end of July and +2.60% at the end of June (all-time low of -0.86% at the beginning of March 2020 and a high of +2.97% at the beginning of October 2023). Likewise, the Spanish 10-year BONOS rate rose to +3.33% at the end of August vs. +3.27% at end-July and +3.24% at end-June (historical low of -0.02% in mid-December 2020 and high of +4.06% at the beginning of October 2023), while the Italian 10-year BTP came in at +3.59% vs. +3.51% at the end of July and +3.47% at end-June (historical low of +0.52% in mid-December 2020 and high of +4.98% in mid-October 2023). The French 10-year OAT also rose, ending August at +3.51% versus +3.35% at end-July and +3.28% at end-June. The OAT/Bund spread thus went from +68bp at the end of June to +66bp at the end of July and +79% at the end of August (this spread was at 53bp at the very beginning of 2024). This significant increase in the France/Germany spread illustrates the markets' doubts that Prime Minister Bayrou will receive a vote of confidence by the Assembly in his favour on 8 September, which would mean a collapse of his government.

Concerning the short-term credit spreads of banking issuers, after widening considerably in April and May 2020 as a result of the health crisis, they continued to shrink over the months that followed, turning negative and decreasing to well below the levels preceding the health crisis! However, the reversal of the ECB's monetary policy and the Russia-Ukraine conflict pushed these spreads back up sharply from the start of 2022. The monthly average issue spreads against Ester of the 3-month certificates of deposit of the main French banks fell very slightly, from +13.5bp in July to +13.3bp in August (all-high time at +25.6bp in May 2020 and lowest at -5.6bp in December 2021) while remaining at historically high levels. The ongoing normalisation of the ECB's monetary policy (with TLTRO III operations fully repaid at the end of 2024) has restored banks' appetite for raising short-term funding.

With regard to the average monthly spread between the 3-month Euribor and the 3-month swap against €STR, which measures the cost of interbank liquidity over this duration, after peaking at +29.5bp in April 2020 at the height of the crisis, it had then collapsed, moving into negative territory for the first time in December 2021 at -0.2bp, reflecting banks' total lack of interest in borrowing cash in the year-end period. In 2022, this spread had widened significantly, reaching +11.2 bp in June (3-month Euribor anticipating the ECB's rate hikes). However, as from July 2022, it had started to drop back, gradually returning to negative territory during the last quarter of the year and hitting a historical low of -10.7bp in February 2023, reflecting the renewed lack of interest of banks to raise cash on the market at the turn of the year 2022/2023. Since then, the spread has moved back into positive territory, reflecting the renewed interest of eurozone banks in raising short-term cash against a backdrop of full repayment of the TLTRO III at the end of 2024. This average spread rose again in August to +11bp vs. +3bp in July, +7bp in June, +11bp in May and +14bp in April, mainly due to the end of expectations of a further cut in the ECB's key rates after the July cut, which had led to a rise in 3-month Euribor rates.

Lastly, with regard to the credit market, the iTRAXX Europe 5-year Corporate IG "generic" index, representative of the average of the 5-year credit spreads of 125 European investment grade corporate issuers, continued to fall after its high of +85bp recorded in early April just after Donald Trump's announcements of the introduction of widespread customs duties on the "Liberation Day" in the wake of negotiations to reach an agreement, which also ended at the end of July, bringing the index to +54bp at the end of July. It rose very slightly to +55bp at the end of August.

During August, in the context of the end of the rate cut cycle in the eurozone, the fund mainly bought assets with a maturity of 1 year or less with variable or adjustable indexation while making investments primarily in fixed-rate assets with short maturities due to the inversion of the yield curve and to not suffer the risk of a negative rerating of long-term fixed-rate assets in the event of volatility on the fixed income markets. As opportunities arose, the fund was able to acquire variable or reversible rate securities with a residual maturity of more than 1 year and up to 2 years, insofar as the margin above 3-month Euribor was deemed sufficient in the current credit market environment with respect to the extension of maturity they bring.

In this context, at the end of August, the fund's WAL was 0.46 (vs. 0.49 at the end of July) and its WAM was 0.04 (0.04 at the end of July).

On a more qualitative level, at end-August, holdings in securities of corporate issuers accounted for 29.1% (32.81% at the end of July), banking and financial issuers made up 61.17% (56.49% at the end of July) and those of sovereign, public and similar issuers 0% (0% at the end of July).

Finally, with regard to the goals of reducing the carbon footprint of the SRI management process set up within the framework of the label, we can note:

- for the segment of "private-sector issuers": the average carbon intensity of this segment of issuers (expressed in tonnes of CO₂ emitted per million US\$ of revenue) stood at 94 at the end of August (122 at the end of July) compared to 221 (222 at the end of July) for the average carbon intensity of the reference Investment Universe. The SRI management process therefore will have led to a 57.5% reduction in August (45.1% at the end of July) in the average carbon intensity of the investments effectively made in these issuers compared to that of the reference Investment Universe, which represents all the investments that could potentially be made in this type of issuer on the basis of credit quality requirements;
- for the segment of "sovereign issuers equivalent": the average carbon intensity of this segment of issuers (expressed in tonnes of CO₂ emitted per million US\$ of GDP) stood at N/S at the end of August (N/S at the end of July) compared to 180 (180 at the end of July) for the average carbon intensity of the reference Investment Universe, as assets of this type of issuers were not held at end-August and end-July. The SRI management process therefore will have led to a NS reduction in August (NS at the end of July) in the average carbon intensity of the investments effectively made in these issuers compared to that of the reference Investment Universe, which represents all the investments that could potentially be made in this type of issuer on the basis of credit quality requirements, as assets of this type of issuers were not held at end-August and end-July.

In the market conditions described above, in August the annualised monthly performance of the IC unit came in at +2.03% (vs. +2.11% in July), i.e. an outperformance of +11bp against Ester (+18bp in July). The R unit posted +1.94% (+2.01% in July), i.e. an outperformance of -2bp against Ester (+9bp in July). Over one year, the performance stood at Ester +10bp for the I unit (+10bp in July), and Ester +1bp for the R unit (flat in July).

In the coming weeks, in a context of a probable status quo for the ECB's key interest rates in September, the management will continue to acquire mostly short-term fixed-rate assets but can go up to 6 months due to the ongoing restructuring of the money-market yield curve while maintaining a reasonable WAM. Given the uncertainties surrounding the trend in credit spreads linked to the current political and economic uncertainties, the fund will maintain a moderate WAL in a cautious approach to avoid suffering the repercussions of a possible further deterioration in credit spreads in the event of an extension of the two current armed conflicts and the trade war initiated by the US and the collapse of the Bayrou government.

Calculation of performance during periods of share class inactivity (if applicable)

For periods when certain share classes were unsubscribed or not yet created (the "inactive share classes"), performance is imputed using the actual performance of the fund's active share class which has been determined by the management company as having the closest characteristics to such inactive share class and adjusting it based on the difference in TERs and, where applicable, converting the net asset value of the active share class into the currency of quotation of the inactive share class. The quoted performance for such inactive share class is the result of an indicative calculation.

Illustrative Growth of 10,000

The graph compares the growth of 10,000 in a fund with that of an index. The total returns are not adjusted to reflect sales charges or the effects of taxation, but are adjusted to reflect actual ongoing fund expenses, and assume reinvestment of dividends and capital gains. Risk Measures

The "Summary Risk Indicator" (SRI), as defined by the PRIIPs regulation, is a risk measure based on both market risk and credit risk. It is based on the assumption that you stay invested in the fund for the recommended holding period. It is calculated periodically and may change over time. The indicator is presented on a numerical scale from 1 (the lowest risk) to 7 (the highest risk). The risk measures below are calculated for funds with at least a three-year history.

Standard deviation is a statistical measure of the volatility of the fund's returns.

Tracking Error is reported as a standard deviation percentage difference between the performance of the portfolio and the performance of the reference index. The lower the Tracking Error, the more the fund performance resembles to the performance of its reference index.

The Sharpe ratio uses standard deviation and excess return to determine reward per unit of risk.

The Information Ratio is the difference between the fund's average annualized performance and the reference index divided by the standard deviation of the Tracking Error. The information ratio measures the portfolio manager's ability to generate excess returns relative to the reference index.

Alpha measures the difference between a fund's actual returns and its expected performance, given its level of risk (as measured by beta). Alpha is often seen as a measure of the value added or subtracted by a portfolio manager.

Beta is a measure of a fund's sensitivity to market movements. A portfolio with a beta greater than 1 is more volatile than the market, and a portfolio with a beta less than 1 is less volatile than the market.

R-squared reflects the percentage of a fund's movements that are explained by movements in its benchmark index, showing the degree of correlation between the fund and the benchmark. This figure is also helpful in assessing how likely it is that alpha and beta are statistically significant.
